

Provison: However, students having reappear in 5th semester shall be allowed to take up the reappear examination in the month of May alongwith 6th Semester.
- That I understand that any optional subject in any semester shall not be offered if less than 25 students opt for it. I undertake not to make a claim for such optional subject.
- 11. That I understand that in case of any illness, medical certificate has to be submitted within a week from the date of joining the department in order to claim the benefit of condonation of lectures.
